

## **2008 Pacific Northwest Junior National Qualifier (TWO Weekends)**

**Weekend 1, March 21-23, 2008 - 12C, 13C, 14C, 14O, 15C, 15O age divisions.**

**Weekend 2, March 28-30, 2008 - 16C, 16O, 17C, 17O, 18C, 18O age divisions**

The tenth Pacific Northwest USA Volleyball Qualifier (PNQ) is scheduled for play at the Spokane Convention Center, Spokane, WA (first/second weekend) and on the campus of Eastern Washington University in Cheney, Washington, a few minutes drive west of Spokane (first/second weekend).

We have teams competing in morning and afternoon waves on approximately 28 courts. This allows us to accept approximately 50 officials: National referees, Junior National referees, Nat'l/Jr.Nat'l candidates who are so verified by their region, local Regional officials, Regional officials from other regions and Referee Chair recommended Provisionals.

If you would like to be a part of our staff, please print and fill out the reply form for officials and send it to me ASAP, no later than **February 29<sup>th</sup>, 2008**. The reply may be sent via email ([bmoe112263@aol.com](mailto:bmoe112263@aol.com)), or regular mail to the address below.

Officials will be paid a daily stipend of **\$150 per day** for working an estimated 6 – 8 matches each day (Friday and Saturday), and 4 – 6 matches on Sunday, (otherwise prorated). We expect to pay the officials as they leave the tournament. We will also provide for **all** out-of-town officials a **shared** hotel room. Your lunch and dinner will be provided on a complimentary basis on officiating days. The tournament will be operating courtesy vehicles for transportation to and from the hotel/playing facilities.

Please bring your complete officiating uniform (standard white official's shirt, navy blue slacks, black belt, white socks and white tennis shoes with the appropriate USAV Official's patch). USAV Official's patches (Regional and Provisional) will be available for sale at the nominal fee for those who do not have one.

The second weekend, March 28–30, 2008, USAV will play host to a Referee Training Camp. This information, along with the camp registration/application forms, will be posted on the USAV website in short order.

There will be **Official's meeting** at approximately **9:00 PM** on **Thursday**, directly after the coaches meeting, on **March 20<sup>th</sup>** and another on **Thursday, March 27<sup>th</sup>**, at the Double Tree Hotel in Spokane. Please make every effort to arrive on time for this meeting. For those flying into Spokane, the hotel(s) runs a courtesy van to and from the airport; the tournament will be operating courtesy vehicles as well.
